- 6. The attached Summary of Changes to Section 513 of the Ordinance relating to Geothermal heating and cooling systems was send to Eric at ESO for his consideration in proposing changes to the section. There will be a public hearing on what Eric proposes.
- 7. The County Board passed a resolution on 8/20th for Eric to draft proposed amended ordinances for the merger of the Planning Commission and Board of

Adjustment with the following general terms: same 5 members for each board (1 from each district), potential right of Co. Board to appoint a chair for each meeting to just run the meetings and with no voting rights, continue the lot viewals, the lot viewals and meetings held during same week, each board would meet on the same day in the evening (BOA meet first then adjourn and the PC meets) and an open and promoted application process with board interviews. We need to follow this process that will go back to the Co.Board so we are prepared to comment, if necessary. The County Board wants to get the PC and BOA ordinances amended and the selection process completed so the new board can be appointed at the December meeting and start work in Jan, 2014.

AIS Task Force Report

Strategic Action #10

- 1. County-wide watercraft inspection program continues to progress well for the summer. We are continuing to line up more inspection support for 2014. Presentations made to Farden Township, South Island Lake, and Lower Crow Wing lake Association. See Julie Kingsley's report for all the details.
- 2. Almost all the Resort information folders have been distributed for this year, with a small survey on what the resort owners can do to help prevent AIS. Survey forms need to be returned to Ken Grob by mid-September at the latest.
- 3. Work to develop a County-wide AIS Rapid Response Plan continues. Bob Berdahl is leading this project. Targeting end of year to have it completed.
- 4. We are working with Beltrami County and Lake Bemidji lake association to help them gain funding for watercraft inspectors next year. We will be talking to Frohn Township (Grace and Wolf Lakes) on September 17. Their proximity to Hubbard County makes it important that they are doing their best at AIS prevention with inspections.
- 5. Julie Kingsley and Ken will be presenting a status report on our AIS programs to the County Commissioners on Sept 3 and to the Association of Hubbard County Townships on September 16.
- 6. State AIS Advisory Committee met on Aug 22. Some key info from meeting:
 - √¹ Hubbard County Inspection Results to date were reported. Lots of interest in our data.
 - $\sqrt{1}$ DNR is receiving USFWS funds (\$425k) for AIS. About half for watercraft inspections. Expected to be incremental to current state funds.

- √¹ Committee toured Lake Minnetonka this summer. We now know what "large" boats are and how hard they are to clean.
- $\sqrt{1}$ Legislative sub-committee is moving slow. Lots of discussion on Lessard-Sams OHF funding, as well as LCCMR and Water Quality Legacy Funds. Sub-Committee needs a more aggressive action plan for the legislative session in 2014. Especially regarding LGU funding.
- $\sqrt{1}$ Communications sub-committee has developed a very comprehensive plan. Focus is on a comprehensive message that is consistent to all citizens and LGU's.
- √¹ Volunteer Watercraft Inspection Program is being completely "reformated". Future Press releases will outline the changes. Changes are significant.
- $\sqrt{1}$ WAPOA Lake Association has requested time with committee to discuss issues with their water shed.
- $\sqrt{1}$ Committee has sent letter to Lessard-Sams OHF Committee in support of the MN COLA Collaborative initiative to fund LGU's.
