f. Hubbard County Community Partners Offers mini grants.

- i. Do you belong to a lake association and want to see some changes made to the lake's shorelines? Is your community or nonprofit organization interested in planting a rain garden? The "Community Partners Conservation Program" through the Hubbard County SWCD is looking for community partners that want to complete projects that will restore, protect or enhance water quality in lakes, rivers and streams. Projects must reduce storm water runoff and provide erosion control on your shoreline. The maximum grant is \$25,000 per group with a required 25% match of cash, in-kind or combination of both.

- g. MN Lakes & Rivers Advocates (MLR) lobby for our lakes. MLR is working to create a group of organized, informed PRIME CONTACTS who will build relationships with legislators and become familiar with the legislative process. By combining a large grassroots base with an organized group of prime contacts and professional advocacy, the lakes will finally get both the funding and legislative support they so desperately need. The Prime Contact Strategy will connect your lake and issues with local and state policy makers, funding opportunities and other activists across the state. As the effort to shield our lakes from Aquatic Invasive Species has made very clear, if we hope to preserve, protect and promote our lakes, we must work together to pass the laws and secure the appropriations lakes and rivers need.

Hubbard COLA will be working with MLR as a partner in their Prime Contact Strategy. We would encourage other lake associations in Hubbard COLA to join MLR and participate in the Prime Contact initiative. - Children's Freshwater Festival on Wednesday, May 7 at Wilderness Boy Scout Camp near Emmaville - <u>contributions are needed</u>. Please send checks payable to Hubbard COLA at PO Box 746 Park Rapids, MN 56470 with Children's Freshwater Festival in the memo line.
- 2. Restore the Shore orders for 2014 will be coming into the Fairgrounds in early May to be repackaged. Volunteers are needed to facilitate this. The Shore Coordinator is Theora Goodrich.
- 3. Veliger Water Testing will be done again in July and August. In 2013, Potato, Blue, Eagle, Big Sand, Little Sand and Long as well as Spider, the Crooked Lakes and Ojibway participated in the testing. No veligers were found. Please let Pete Tuomisto know if your lake will continue testing in 2014 and if your lake would like to participate for the first time in 2014. I will be making blocks available (to hang on the end of docks) at each COLA meeting. We want more testing and monitoring!
- 4. Hydro Lab SWCD will again have the Hydro Lab testing for those interested lakes in 2014. This is for monitoring the dissolved oxygen and the water temperature in your lake. Please see Julie Kingsley at SWCD if interested. There will be a charge for SWCD to perform this test. SWCD will also Veliger Sample and Map Vegetation for a fee. Contact SWCD if interested.
- 5. Water Monitoring Kits will be handed out on May 14th at 7:00 p.m. at the Courthouse. Training will be available if needed. We are in need of someone to transport the samples to Detroit Lakes once a month. A truck with topper is needed.
- 6. Civic Committee meeting will be meeting March 7 at 2:00 pm at SWCD. Firm dates for the above activities will be established at the meeting and reported at the next COLA

meeting. Those attending will be Pete Tuomisto, Jerry Knoblich, Bert Ahern, Sharon Natzel, Theora Goodrich, and Julie Kingsley. Others interested in helping out are encouraged to attend.

AIS Task Force Report

Strategic Action #10

- 1. County-wide watercraft inspection program targets for 2014 have been established for each lake. SWCD working to obtain commitments for 2014 by end of February, so hiring planning can begin.
- 2. Detailed 2013 reports on watercraft inspections have been distributed to each lake association and township/city as appropriate. Overall summaries can be found on COLA website. Click on AIS and then County AIS Task Force link.
- 3. A Resort Support Sub-Committee (under COAL AIS Committee) has been organized to work with resorts in 2014 on guest awareness.
- 4. Work continues on developing a County-wide AIS Rapid Response Plan. An initial draft was presented to the County AIS Task Force last week. Bob Berdahl is leading this project. Targeting late summer to have it completed.
- 5. Ken Grob and Jeff Bjorkman presented an update on our AIS programs and the 2014 Watercraft Inspection Program goals at the November COLA Meeting. Presentation can be reviewed on the COLA website: Click on General Info and Committees; Click on COLA AIS Committee; It is listed as 10/31/2013 presentation. This is a good summary of our initiatives and strategy.
- 6. County AIS Task Force has set goals for 2014. Please see website for list of 2014 Goals.
- 7. State-wide DNR AIS Advisory Committee has published their Annual Report. Excellent document. See COLA website to review. Click on AIS-DNR Link. In this folder there are also two letters that Ken Grob has sent to the committee. One outlines a strategy for long term sustainable funding for LGU's and the other is a summary of Hubbard County's 2013 accomplishments.
- 8. The COLA website (AIS Folder; DNR Link) also has information on the Lake Mille Lacs walleye population crisis.
- 9. LAKE ASSOCIATIONS NEED TO COMPLETE WATERCRAFT INSPECTION COMMITMENT LEVELS FOR 2014. Actions needed:
 - $\sqrt{1}$ Lake associations need to decide/commit to the level of inspections they want in 2014. This should be done no later than the end of February.
 - $\sqrt{1}$ Obtain commitments from lake residents (lake association) for 2014 financial support level.
 - √¹ Contact their Townships/Cities to indicate what is needed for support in 2014 (same as 2013 or more)
 - $\sqrt{1}$ Attend township annual meeting on March 11 to confirm support for 2014 and insure funds for 2015 are included in budget recommendations.
