Year one of the program engages respected citizen leaders in five workshops (in-person and online) that provide opportunities for growth and collaboration. Year two will focus on emerging leaders and will begin late summer. On Tuesday, April 22nd, the House Tax Committee will hold an informational hearing on HF 2855 that would send, if passed, \$10 million *annually* in County Program Aid to counties to fund AIS work within those counties.

Local lakeshore owners and governmental units have been raising and spending millions of dollars in an effort to protect the public waters with little help from the state. With HF 2855 the state is poised to commit \$10 million a year to support these local efforts. MLRA has been lobbying this bill very hard working with both legislators and county officials on this proposal.

Contact your legislators and county commissioners and urge them to support this innovative funding solution for lake protection.

- 4) Also there is a FM Walleye Educational Event coming up on May 15 at 7 PM at the Doublewood Inn in Fargo, ND. Carpool leaves at 4:30 PM. So hold the date.... Sounds like a panel with multiple people and dealing with water issues such as AIS on a turnament lake.
- 5) A Course on Basic Plant / Lake Ecology and Basic Aquatic Plant Identification with plant key, herbarium, and live plants is being planned for Friday, August 8TH from 4:30 PM to 9 PM at Northwoods Bank Community Room. Mary Blickenderfer, UMN will provide the training and the live plants. We are working with Sally Shearer, Hubbard County UMN Extension to coordinate and offer this training free of charge for the attendee. Pizza / Pop will be provided for students by the Hubbard County COLA Education Team.
- 6) Nevis's Week of the Young Child contacted the Hubbard County COLA Education Team to participate with a class offering. The Friday, 4/11/14 Aquatic Investigation event focused on the young child and their relationship with the creatures of the lakes and rivers and their water environment. The Hubbard County Coalition of Lake Associations Education Team sponsored the event at School Readiness from 3 to 5 PM and included team members Jan Rumpza, Julie Kingsley and Sharon Natzel. The event was attended by 30 children and over 10 adults. "Gold Fish" and other snacks were enjoyed by all. The educational stations included the following:
 - a. Bingo checklist for the live creatures in the water (special thanks to Northern Bait Company in Park Rapids and Julie Kingsley for the variety of macroinvertebrates)
 - b. The Lake Game with age-appropriate questions where the children had the opportunity to answer what they would do in certain situations. These decisions then determined the condition of "the lake" in the tub... For example, would they rake just a bit of vegetation by the swimming dock, leaving some for fish habitat or use a chemical to remove all the vegetation in the large area...
 - c. The Shoreline Habitat demonstration table allowed the children to observe the water's reaction when sprayed from a bottle onto a rock's hard surface simulating wave action and into a soft moss mat which absorbed the water
 - d. Many of the children enjoyed creating Frogs and Turtles using paper plates and construction paper, coloring water-related creatures like fish, heron, frogs, stamping frog tracks on lily pads, and some crossword puzzles with water-related creatures went home in bags for future studies.
- 7) Please provide your suggestions for speakers / topics for upcoming HC COLA meetings to the Education Team. For example, in our educational survey last year in partnership with the UMN, we identified Shorelands, Aquatics and Groundwater as topic areas of interest. Let us know if there are others too!

- Children's Freshwater Festival on Wednesday, May 7 at Wilderness Boy Scout Camp near Emmaville - <u>contributions are needed</u>. Please send checks payable to Hubbard COLA at PO Box 746 Park Rapids, MN 56470 with Children's Freshwater Festival in the memo line. Volunteers should contact Melissa at the SWCD.
- 2. Restore the Shore orders for 2014 will be coming into the Fairgrounds in early May to be repackaged. Volunteers are needed to facilitate this. The Shore Coordinator is Theora Goodrich.
- 3. Veliger Water Testing will be done again in July and August. In 2013, Potato, Blue, Eagle, Big Sand, Little Sand and Long as well as Spider, the Crooked Lakes and Ojibway participated in the testing. Belle Taine Fish Hook and Kabekona are showing interest for 2014.No veligers were found. Please let Pete Tuomisto know if your lake will continue testing in 2014 and if your lake would like to participate for the first time in 2014. I will be making blocks available (to hang on the end of docks) at each COLA meeting.
- 4. Hydro Lab SWCD will again have the Hydro Lab testing for those interested lakes in 2014. This is for monitoring the dissolved oxygen and the water temperature in your lake. Please see Julie Kingsley at SWCD if interested. There will be a charge for SWCD to perform this test. SWCD will also Veliger Sample and Map Vegetation for a fee. Contact SWCD if interested.
- 5. Water Monitoring Kits will be handed out on May 14th at 7:00 p.m. at the Courthouse. Training will be available if needed. We are in need of someone to transport the samples to Detroit Lakes once a month. A truck with topper is needed. Further information and program registration forms will be sent electronically to lake associations.

AIS Task Force Report

Strategic Action #10 By Ken Grob

- 1. County-wide watercraft inspection program is in full swing. Nate Sitz will present details at the meeting. Nate reports that lake associations have committed to about 8400 hours (a 25% increase over 2013). 26 lakes with 30 accesses will be covered. The County Commissioners have allocated \$35,000, and the DNR has funded two inspector grants. A Level 1 inspector (\$4000) and a Level 2 inspector (\$8000). The Level 2 inspector is critical to our strategy because it provides some coverage for our decontamination station, which will be available at no cost to users. This will be very beneficial to our inspectors and to resort owners.
- 2. DNR has issued its annual report to the legislature on AIS for 2013. It is a very informative report. Jeff Moser has posted it on the COLA website.
- 3. DNR has finalized the Volunteer Inspection program for 2014. It has significantly changed. See the excerpt from my email to all AIS Coordinators below: "The DNR has not published the details on the volunteer process. That will come in the next few weeks. However if your lake association intends to train and conduct volunteer inspections you need to sign up for one of the scheduled inspection dates/locations. Location and time information is on a Link that is posted on the COLA website. Unfortunately none of the training sessions are scheduled in Park Rapids. I am working on that. Lake George session is on May 3, Walker on May 7, and Detroit Lakes on April 16. Note that all of your association volunteers do not have to go to the same training session.
- 4. A Resort Support Sub-Committee (under COLA AIS Committee) has been organized to work with resorts in 2014 on guest awareness. We have submitted an application for a Public Awareness Grant from the DNR to cover 50% of expenses.
- 5. Lake Monitoring Training Sessions have been scheduled around the state. None currently scheduled in Park Rapids, but I have asked for one. If we have enough interest, I can get one scheduled locally. See www.conservationminnesota.org (Click on "lakes, rivers, and waters", then click on "2014 AIS monitoring trainings") for location of sessions.
- 6. There are two state level initiatives underway to provide funding for Local Government Units (LGU's) for AIS prevention. The LSOHC funding to the Initiative Foundation (\$4MM) for pilot programs (2 year funding program) and 2014 Legislative Bill SF2342 introduced by Sen Skoe to provide \$10MM to LGU's for AIS. Hubbard County would receive about \$265K under the current bill. Legislative Committee hearing is on Tuesday, April 22.
- 7. Dates to remember:
 - √¹ LSP Training for Resort Owners was held on April 9 in Walker (Hiawatha Beach Resort) as part of the Congress of Minnesota Resorts Conference (Email has been sent to Resort Owners). Nate Sitz attended and communicated Hubbard County info on watercraft inspection and our decontamination station for 2014.
 - √¹ Lake Monitoring Training on May 1&2 as part of the "State of Waters" Conference in St. Cloud. Ken Grob will be a speaker at the conference on May 2 on watercraft inspection program.
 - √¹ UMISC Conference in Duluth October 20-22. This is an excellent conference on AIS. It is the Upper Midwest Invasive Species Conference that is sponsored every other year.
