The President will then provide the requests to the ESO on June 15 and October 15 of each year.
- 2. The combined Planning Commission and Board of Adjustment is working well and a big improvement over the former system.

Civic Committee activities for 2014

- 1. Children's Freshwater Festival on Wednesday, May 7 at Wilderness Boy Scout Camp was a success.
- 2. Restore the Shore orders for 2014 came into the Fairgrounds in early May and were repackaged and picked up. Our thanks to Theora Goodrich and her crew.
- 3. Veliger Water Testing will be done again in July and August. In 2014, Potato, Blue, Eagle, Big Sand, Little Sand, Long, Spider, the Crooked Lakes, Ojibway, Belle Taine, Fish Hook and Kabekona will be participating. Please let Pete Tuomisto know if your lake would like to participate for the first time in 2014. I will be making blocks available (to hang on the end of docks) at each COLA meeting.
- 4. Hydro Lab SWCD will again have the Hydro Lab testing for those interested lakes in 2014. This is for monitoring the dissolved oxygen and the water temperature in your lake. Please see Julie Kingsley at SWCD if interested. There will be a charge for SWCD to perform this test. SWCD will also Veliger Sample and Map Vegetation for a fee. Contact SWCD if interested.
- 5. Water Monitoring Kits were handed out on May 14<sup>th</sup> at the Courthouse. We could still use another person to help transport the samples to Detroit Lakes once a month on Mondays. Please let Pete Tuomisto know if you can help. Invoicing for the Monitoring will be sent out in June.

# **AIS Task Force Report**

Strategic Action #10 By Ken Grob

- 1. County-wide watercraft inspection program is in full swing. Julie Kingsley will present details at the meeting. Nate Sitz reports that lake associations have committed to about 8200 hours (a 25% increase over 2013). 26 lakes with 30 accesses will be covered. The AIS watercraft decontamination station will be operating with dedicated staff on Friday afternoons and Saturdays starting on May 30. Location is on road to Waste Management facility in Park Rapids. No cost to users.
- 2. Minnesota legislature and Governor have signed bill to provide AIS funding to all counties in Minnesota. Total state-wide is \$10 million. This is a major step forward for AIS prevention and will provide some funding for Hubbard County. Lots of details and work to do by County AIS Task Force to develop plan. Although some funds will be available later this year, we do not plan to change any of the lake association or township commitments for watercraft inspection funds this summer.
- 3. There does not seem to be any interest in volunteer inspection training this year. Dan McCorry will update status at meeting.
- 4. The Resort Sub-Committee has assembled the resort visit folders and will be distributing them to the contact person for each lake at the COLA meeting. We plan about 60 visits again this year. Lots of new info and we will promote sending resort guests to the SWCD decontamination station. Contact persons are requested to attend the COLA meeting at 6:00 p.m. to receive their folders.
- 5. We have arranged for a special Lake Monitoring Training Session for Saturday, June 7 in Park Rapids. We have commitments for 27 attendees. Session will be at the Park Rapids Public Library 9-11 a.m. See www.conservationminnesota.org (Click on "lakes, rivers, and waters", then click on "2014 AIS monitoring trainings") for more information on the session. Meredith Keller of Conservation Minnesota will do the training. No cost to

- attendees. I AM IN NEED OF A PERSON(S) TO HELP WITH THE MEETING (Get key and set up for meeting, as I will not be available). Looking for a volunteer!!!
- 6. We have received a Public Awareness Grant from the DNR again for 2014. Bob Berdahl has completed arrangements for radio public service announcements on local radio stations and for the road side billboards in the area. Grant also helps pay for the resort folders

  - $\sqrt{-1}$  UMISC Conference in Duluth October 20-22. This is an excellent conference on AIS. It is the Upper Midwest Invasive Species Conference that is sponsored every other year.
