Civic Committee activities for 2015

- 1. Veliger Water Testing training will be done on Monday June 29th at 1:00 pm. It will be held at the Blue Lake access. In 2014, Potato, Blue, Eagle, Big Sand, Little Sand, Long, Belle Taine, Kabekona, Fish Hook as well as Spider, the Crooked Lakes and Ojibway participated in the testing. No veligers were found. Next Monday volunteers from MCWLA, Boulder, Duck, Big Mantrap, Bottle will get training in Veliger monitoring. All lakes doing the monitoring this year are welcome to get a refresher course next Monday. Testing should be done in conjunction with the July and August Water Monitoring weekends so as to transport the Veliger samples to DL. Remember, the Veliger samples do not have to be refrigerated and can be done ahead of the Water Monitoring. I will be making cinder blocks available (to hang on the end of docks) at each COLA meeting.
- 2. Hydro Lab SWCD will again have the Hydro Lab testing for those interested lakes in 2015. This is for monitoring the dissolved oxygen and the water temperature in your lake. Please see Julie Kingsley at SWCD if interested. There will be a charge for SWCD to perform this test. SWCD will also Veliger Sample and Map Vegetation for a fee. Contact SWCD if interested.
- 3. Water Monitoring is going on as scheduled. May and June have been collected and sent to the RMB Labs for testing and recording. The next collection weekend is July 19 with samples returned to Charlie's Boat and Marine on Monday (July 20) as early as possible. The transportation to DL would like to leave before noon to avoid the rush at the Labs. The last two weekends of Monitoring are Aug 16 and 17, and Sept 20, and 21.

Sandpiper Pipeline Update

- 1. On June 5th, the PUC Commissioners approved a Certificate of Need for the Sandpiper pipeline. Click here for full announcement from PUC. Hearings for the Certificate of Route will we be announced soon. A Comprehensive Environmental Assessment (CEA) will begin shortly on the two routes left under consideration. Both of these routes cross the headwaters of the Mississippi and Hubbard County. Friends of the Headwaters (FOH), a local group opposed to routes through our lake country, is exploring various legal options.
