- Veliger Water Testing has been completed for this year. RMB Labs has found no veligers in our samples. Veligers are too small to see without a microscope but we can keep vigilant on the adult Zebra Mussels. Make sure to examine docks, boatlifts, pontoons, etc. as you take them out of the water for the winter. Also, as for the cinder blocks, please examine those also as you take the dock out. It is important for dock and lift service providers to also examine those docks and lifts as they take them out of the water.
- 2. Water Monitoring has finished for the year. September samples have been collected and sent to the RMB Labs for testing and recording. If you haven't returned the collecting tube to Charlie's, please do so. They will be cleaned and dried and stored for the winter.
