Veligers are too small to see without a microscope but we can keep vigilant on the adult Zebra Mussels. Make sure to examine docks, boat lifts, pontoons, etc. as you take them out of the water for the winter. Also, as for the cinder blocks, please examine those also as you take the dock out. It is important for dock and lift service providers to also examine those docks and lifts as they take them out of the water.
- 2. Water Monitoring has finished for the year. September's samples have been collected and sent to the RMB Labs for testing and recording. If you haven't returned the collecting tube to Charlies, please do so. They will be cleaned and dried and stored for the winter.

Pipeline information update

Appeals Court rules that the PUC "jumped the gun"...rescinds Cert of Need permit and requires EIS...MN Supreme Court to weigh in next

This past winter, Friends of the Headwaters (FOH) and its legal representative, the Minnesota Center for Environmental Advocacy (MCEA) initiated an appeal regarding the necessity for an Environmental Impact Statement (EIS) on the Enbridge's proposed Sandpiper pipeline. On September 14th the MN Court of Appeals ruled that the PUC must conduct an EIS prior to deciding whether to approve a Certificate of Need permit to Enbridge.

In this unanimous decision, the Court concluded that "MEPA requires an environmental impact statement to be completed before a final decision is made to grant or deny a certificate of need." As a Mpls <u>Star Tribune</u> article pointed out: "The Friends of the Headwaters argued that conducting certificate of need proceedings before completing an environmental impact statement violated the Minnesota Environmental Policy Act. The appeals court agreed."

Subsequent to this Appeals Court ruling, on October 14th both Enbridge/NDPC and the MN PUC filed a petition requesting the MN Supreme Court review this ruling. The MN Supreme Court has 60 days to decide whether it will hear this case. These rulings have important ramifications for Minnesota as they will set precedent for this and future pipeline projects.

Friends of the Headwaters believes that, IF oil pipelines are needed, they should be located away from Minnesota's most pristine water resources.
