AIS Citizen Watch Volunteers – Let's keep our "Eyes on the Water" for AIS in 2017. By Dan Kittilson

HC COLA strives to inspire our lake association members and lakeshore property owners to become involved and raise the level of awareness and observations around aquatic invasive species. Lake associations are encouraged to review their current level of participation in HC COLA'S AIS Lake monitoring program and endeavor to expand your AIS Lake Monitoring program in 2017.

In 2016, HC COLA was effective in engaging more lakes and lakeshore property owners, who were monitoring their lake for zebra mussels. During our 2016 campaign, 24 lake associations and one non-member lake group participated in our AIS Lake monitoring program. For our early detection program to be effective, we need to further expand our eyes on the water looking for AIS.

In 2017, HC COLA continues to expand our AIS Citizen Watch Volunteers. Citizen watch volunteers are lakeshore residents who monitor their lake for AIS, including zebra mussels and invasive plants. Citizens can inspect their lake shore equipment, shoreline habitat and monitoring devices such as settlement samplers, cinder blocks and PVC tubes for AIS.

Again this year, HC COLA will be implementing our **on-line survey** that will focus on monitoring for zebra mussels and other invasive species. This year we will expand our on-line survey to include monitoring efforts for invasive plants, such as Starry Stonewort or Eurasian Water Milfoil.

In early September AIS citizen watch volunteers will be receiving a survey, because of their participation / relationship with the Hubbard County COLA AIS Lake monitoring early detection program. We invite you to participate in this very important study concerning the early detection of AIS, especially zebra mussels in Hubbard County lakes.

The goal of this study is to expand our communication and outreach for AIS Lake monitoring and to increase our number of "eyes on the water" in Hubbard County looking for AIS. If you do not have a special monitoring devices (such as a settlement sampler) on your lakeshore, HC COLA's on-line survey can still provide an opportunity for you to inspect your shoreline and lake shore equipment for zebra mussels and other AIS.

Last year our on-line survey focused mostly on our AIS Citizen Watch volunteers who had zebra mussel monitoring devices. Our **2017 on-line survey** will be expanded to include AIS Lake Coordinators and Lake Association Presidents, who in turn can invite all their lake association members to participate in this very important matter.
