
# HC COLA Mid-Summer Update





## Response Plan on Starry Stonewort AIS in Wolf Lake: HC COLA, both Hubbard & Beltrami County AIS Programs, DNR & Others

- Access signage & kiosks
  - 1 volunteer builder ID'd as PR Eagle Scout project for WMA undeveloped access where SSW was identified in Starry Trek
  - 1 volunteer builder still needed for public access
- Landowner letter mid March
- Informational Mtgs May & June
- SSW identification class on the water in July for Wolf Lake landowner team
- Caution AIS buoys
  - Avoid chopping the SSW by lifting motor as fragments spread it
- Monitoring
- Car counting
- Survey of Starry Stonewort in July 2019 by DNR
- Coaching / mentoring Wolf Lake Residents and water-users to prevent the spread within the lake and to other waterbodies
