The AIS prevention billboard and movie theater ad we share with the county AIS program are in place for the season; printed bait bags were delivered and posters were provided at water cooler Wed.

The aquatic vegetation removal station that the Long Lake Area Assoc (Hubbard County) purchased for their north and south accesses have been installed. The hope is that vegetation will be removed before and after launching to prevent the spread of AIS between waterbodies. (The initial ZM found at Long in July 2020 was clasping onto a pondweed at the south access).
