E-Team

AIS Operating Team:

HC COLA AIS Operating Team met with Nick Macklem via zoom on 8/17/21:

Nick Macklem reported that AIS inspections are ongoing with most shifts being filled as scheduled.

Nick discussed the discovery, by an AIS inspector, of live zebra mussels attached to the sea legs on a pontoon boat leaving the Nevis access from Lake Belle Taine. The pontoon boat had been at a local resort on the lake for a week, and had come from lake(s) in the Alexandria area known to be infested with zebra mussels. The zebra mussels were found when vegetation found on the sea legs was being removed. Nichole Kovar from the Minnesota DNR agreed that it is likely the zebra mussels were on the boat before it was launched into Lake Belle Taine and will not list Lake Belle Taine as an infested lake at this time. The Lake Belle Taine Association will do additional sampling and AIS inspectors will closely monitor boats leaving the lake. Nick will follow up on Conservation Officer ticket action in Alex area regarding the boat owner. The pontoon entered the lake in the evening after watercraft inspection hours. We will ask Nicole Kovar, DNR Invasive Species Specialist and Andrea Dutcher, HC COLA Rep to share an update for the HC COLA August meeting too.

Nick indicated that the Hubbard County decon station is looking at getting a sprayer mounted on wheels to better access under trailers.

Nick indicated that next year the lead AIS inspector will be making an effort to spend one day a week visiting resorts to advise them on AIS mitigation methods.

Sharon discussed the repairs to the Wolf Lake kiosk which has been damaged by vandals on several occasions. The South Big Wolf Lake Association arranged for the repair and additional buoys placement also to keep boats in access channel.

Sharon indicated that additional ZMV and SWF sampling kits will be available at next year's water cooler Wednesday pick up day. This year, there weren't enough sampling kits to meet the demand on that particular day. [Note: RMB is willing to mail out additional sample bottles at no charge if a water quality monitor discovers a shortage of bottles far enough ahead of sampling day.]

Sharon discussed the use of aqua week sticks at the Long Lake accesses. She provided the following cost information for consideration for use by the Hubbard County AIS inspectors as follows: 2-4 Ft extendable aqua weed stick from Wildlife Forever is: \$25.50 each so 50 would be \$1275 plus tax plus shipping; They also have a 3-6 Ft extendable aqua weed stick for \$27 each so 50 would be \$1350 plus tax plus shipping.

The HC COLA Starry Trek team of 11 volunteers searched 19 accesses on 18 northern Hubbard County Lakes for Starry Stonewort and other AIS on Sat 8/21/2021. We trained at the Wolf Lake Wildlife Management Area undeveloped access where Starry Stonewort was discovered during Starry Trek in 2018. We used separate rakes and different shoes at each access to prevent the spread of any AIS. We did not find any unknown AIS in our sampling at those 19 sites.
