Peter thanks all the water monitors who sampled this past Sunday and got their coolers to the Chamber of Commerce on Mon by 11 AM. Please check your June cooler now to make sure you have things you need and/or if you need zebra mussel veliger sampling bottle(s) for your plankton net testing for late June and around the second week in July so the bottle(s) that are preserved with 91% alcohol can be turned in with the Mon July 18th cooler. If you are missing something, please let Peter know now.

#### 3) Restore the Shore:

Cheryl Hilgeman - Middle Crow Wing Lakes Assoc is our Coordinator for our HC COLA Restore the Shore (RTS) order and did a wonderful job of juggling the changing schedule with our late spring! Cheryl reports that all orders were delivered to the lake association RTS coordinators on May 13 & 14th. There were 13 LA participating this year. (We've had 12-14 each of the last 3 years!) Stay tuned as the process will likely be updated again next year. Many good options will continue to be available for shoreland improvement and restoration.
